On the daily chart the current upward gap area is in the range of 19011 to 19024. Normally, upward gap area does act as support for prices. In coming trading session if nifty trades above 19201 levels then it is likely to test 19290 - 19310 levels. On the downside, 19100 - 19000 levels may act as support for the day.

Since, indices is trading at life time high we are of the opinion that one needs to adopt positive approach at current level as stock specific activity is likely to continue.
