Market Technical Outlook

Sensex ended with gains of 0.30% whereas Nifty gained 0.19% W-o-W.

Pattern Formation: On the Weekly charts, we are observing two consecutive narrow range body formations with higher high. This suggests that markets are cautiously positive at current levels. On the daily charts, we are observing strong bear candle with higher volumes. This suggests that momentum on the downside is likely to continue.

Outlook: Combining the two above conflicting patterns it is evident that markets are circumspect at current level. At present Nifty has resistance at 11906 - 11960 - 12022 levels whereas on the downside it has support at 11715 - 11662 - 11599 levels. In coming week if Nifty trades and close above 11852 level then it is likely to test 11906 - 11960 - 12022 levels. However, if Nifty trades and close below 11769 level then it can test 11715 - 11662 - 11599 levels.

We maintain our stance, that 11600 is a make or break level. Hence as long as Nifty hold 11600 level there is high probability that Nifty may test 11906 – 11960 – 12022 levels.
