Nifty opened higher but was unable to sustain the opening gains and selling pressure intensified as the day progressed which led the indices to close near days low. On the daily chart, we are observing that a price have tested the demand zone of 11895 to 11800 and has closed within it. Hence a bounce from current level cannot be ruled out.

In coming trading session we would like to give two scenarios.

- 1. If Nifty open in the range of 11897 11950 levels then go short with a stop loss of 11980 for a target of 11830 11814 11770 levels.
- 2. If Nifty open down with a gap then buy in the range of 11825 11814 with a stop loss of 11800 for a target of 11881 11897 11923.
