### Market Technical Outlook

On 11/02/2019 markets opened lower traded with negative bias throughout the day to close in red. On the sectorial front Oil & Gas, Capital Goods and Auto led the fall whereas IT and Teck ended with marginal gains. The advance decline ratio was in favour of declining counter (Advances= 835 Declines= 1714).

**Pattern Formation**: On the Daily Chart prices has tested the 200-day SMA(10857) and has closed above it.

**Outlook**: The current price action on the daily chart suggests that 10830 on the down side and 10940 on the upside remains crucial zone. Any decisive break on the either side would dictate the direction of the trend. In coming trading session if Nifty for first hour holds 10830 level then it can test 10950 - 11000 levels. On the flip side if it breaks 10830 level then it may test 10800 - 10770 levels.
