Nifty opened higher traded with choppiness but finally managed to close in green. On a daily chart, we are observing six consecutive narrow range body formations with higher high. This suggests that markets are cautiously positive at current level. However, prices have closed convincingly above the major supply of 11794 (shown above in the graph in pink color). In coming trading session if prices trade above 11938 levels then it may test 12000 - 12100 levels. On the downside, 11800 - 11700 levels may act as support for the day.

Since the prices have closed above 11794 levels the trend has turned up and momentum on the upside is likely to continue. However, a minor pull back cannot be ruled out. We maintain our stance that stock specific activity is likely to continue.
