Nifty, opened higher and momentum on the upside intensified as the day progressed which led nifty to close in green. On the daily chart, we are observing that prices have closed convincingly above the 10-days SMA (18599) and formed a bull candlestick pattern. At present, prices are trading within the upward slopping channel (shown above in the graph). In coming trading session if nifty trades above 18740 level then it is likely to test 18810 – 18887 (All-time high) levels. On the downside, 18610 – 18530 level may act as support for the day.

We still continue to maintain or stance that looking at the major pattern of inverse head and shoulder formed above 17900 level suggests that market is heading to test all-time high or even head higher in couple of weeks. Hence, one needs to adopt positive approach at current level as stock specific activity is likely to continue.
