Market Technical Outlook



Nifty opened down with a gap but recovered all its losses during the day to close marginally in green. We still maintain our stance that on the daily chart, 19300 to 19500 zone which was first acting as resistance may act as support for price (change of polarity). At present, prices on intraday basis breached 19300 levels but have closed above it. Further, we are seeing that 50-day SMA (19258) acted as support for the prices and formed a candlestick pattern that resembles a bullish Hammer. The said pattern would get activated once nifty trades and closes above 19465 level. In such scenario nifty may test 19540 – 19650 levels. On the downside, 19320 – 19250 levels may act as support.

We continue to maintain our stance that looking at current price action, it is evident that 19300 on daily closing period remains a make or break level. We still maintain our stance that a time wise consolidation or a minor correction from current level cannot be ruled out. Since, the trend remains up one needs to adopt buy on decline strategy. However, stock specific activity is likely to continue.
