Market Technical Outlook



Nifty opened on a subdued note but momentum on the upside intensified as the day progressed which led the indices to close in green. On the daily chart we are observing that prices have closed above the 21-day SMA with a bull candle. **We still maintain our stance that Nifty is in a lower- top lower- bottom formation. However, any close above 11106 would negate the said pattern.**

In coming trading session if Nifty opens lower in the range of 11043 to 11022 then, go long, with a stop loss of 10965 for a target of 11108 – 11141 – 11180 levels.
