Market Technical Outlook



Nifty, opened higher traded with choppiness but finally close marginally in green. On the daily chart, we are observing that prices have tested the lower trendline of the falling channel and formed a "Doji" candlestick pattern. This suggests that the prior downtrend is losing breath. We maintain our stance that 16900 - 16800 is a strong demand zone, hence a bounce from current level cannot be ruled out. In coming trading session if nifty trades above 17062 then it may test 17110 - 17230 levels. On the downside, 16900 - 16800 may act as support for the day.

We still maintain our stance that prices for four consecutive trading session has convincingly close below the rising 200-days SMA (17449). Hence, one needs to adopt cautious approach at current level.
