Nifty opened on a subdued note but witnessed selling pressure in the latter half of the session which led the nifty to close in red. We still maintain our stance that prices are trading within the supply zone of 11036 to 11433 (shown in red in the above graph). Further, prices have tested the upward sloping trendline and have closed marginally above it (shown in blue in the above graph). In coming trading session if prices trade below 11100 then it may test 11000 - 10900 levels. On the upside, 11300 - 11400 levels may act as resistance for the day.

We still maintain our stance that Nifty is trading within the supply zone of 11036–11433. Hence cautiously positive approach should be adopted at current level as stock specific activity is likely to continue.
