Nifty opened down with a gap and momentum on the downside intensified as the day progressed which led the indices to close deep in red. On the daily chart we are observing a negative divergence in the RSI. Further, prices have given close below the 20-day SMA (17681). This suggests that momentum on the downside is likely to continue. In coming trading session if nifty for first hour trades below 17495 level then it may test 17280 – 17190 levels. On the upside, 17650 - 17730 levels may act as resistance for the day.

Since, prices have closed below the 20-day SMA (17681) we are of the opinion that momentum on the downside is likely to continue. Hence one can trade with cautiously positive bias and stock specific activity is likely to continue.
