Market Technical Outlook

On 19/06/2019 markets opened higher traded with extreme choppiness and finally managed to close on a flat note. On the sectorial front, Realty, Consumer Durable and Metal ended on the gainers side whereas Utilities, Healthcare and Oil & Gas ended on the losing side. The advance decline ratio was in favour of declining counter (Advances= 700 Declines= 1867).

Pattern Formation: On the Daily Chart, we are observing two consecutive narrow range body formation which suggests indecisiveness prevailing at current level.

Outlook: The current price action on the daily chart suggests that 11590 remains crucial support for the markets. In coming trading session, if Nifty trades above 11720 level then it is likely to test 11750 – 11790 levels. On the downside 11650 – 11590 levels may act as support for the day.

At present one needs to adopt cautious approach at current level.
