On 20/06/2019 markets opened lower but witnessed upside momentum in the latter half of the session which led the indices to close in green. On the sectorial front, Capital Goods, Consumer Durable, Auto, Realty and Healthcare led the rally. The advance decline ratio was in favour of advancing counter (Advances= 1530 Declines= 1010).

Pattern Formation: On the Daily Chart, we are observing strong bull candle which has taken support near the gap area of (11591 to 11426).

Outlook: The current price action on the daily chart suggests that momentum on the upside is likely to continue. In coming trading session, if Nifty trades above 11850 level then it is likely to test 11900 - 11950 levels. On the downside 11800 - 11740 levels may act as support for the day.

At present one need to adopt cautiously positive approach at current level as stock specific activity is likely to continue.
