Nifty opened gap down and traded in a narrow range with negative bias throughout the day to close in red. At present, price still trade within supply zone, which is 11036 to 11433. In coming trading session if prices trade above 11370 levels then it is likely to test 11420 - 11450 levels. On the downside, 11250 - 11200 levels may act as support for the day.

On the daily chart we are observing "Doji" candlestick formation with downward gap area, which indicates consolidation will remain, continue. Broadly, we are of the opinion that if Nifty manages to close comfortably above the supply zone of 11036 to 11433 with good volumes then we could see levels of 11600 – 11800 levels in couple of weeks. Hence cautiously positive approach should be adopted at current level as stock specific activity is likely to continue.
