

Nifty, opened on a subdued note trade in a narrow range with positive bias to close in green. On the daily chart, we are observing series of narrow range body. This suggests that markets are cautiously positive at current level. In coming trading session if nifty trades above 13780 levels then it may test 13900 - 14000 level. On the downside, 13600 – 13500 levels may act as support for the day.

At present the prices have tested the 127%Fib levels (13758 shown above in the graph) and have closed marginally above it. However, if Nifty closes above the mentioned level with good volumes for two to three trading sessions then nifty is likely to head towards Fib161.8% (15470 shown above in the graph) in couple of months. Hence, one needs to adopt positive approach towards the market.
