Nifty witnessed smart rally in wake of positive announcement by the finance minister about reduction in corporate tax rate. On the daily chart we are witnessing a strong bull candle which has closed above the 200 & 50 - days SMA. The rise was supported by higher volumes which suggest that momentum on the upside is likely to continue. Further, on the daily chart Nifty has reversed its trend to higher top - higher bottom formation (as shown above in the graph HT - HB).

In coming trading session if Nifty opens lower in the range of 11192 – 11111 then, go long, with a stop loss of 10940 for a target of 11380 – 11437 – 11538 levels.
