This suggests that the uptrend may reverse. In coming trading session if prices trade below 11084 then it may test 11000 - 10950 levels. On the upside 11250 - 11350 levels may act as resistance for the day. Broadly, we are of the opinion that 11000 - 11100 is strong demand zone, hence a bounce cannot be ruled out from current level.
