Nifty, opened on a subdued note but momentum on the upside intensified in the latter half of the session which led nifty to close in green. On the daily chart, we are observing that prices have reclaimed 21-day SMA (14806) and closed well above it. In coming trading session if Nifty trades above 15010 then it may test 15150 - 15250 levels. On the downside, 14800 - 14600 levels may act as support for the day. We maintain our stance that the upward gap area in the range of 14336 to 14469 (formed on 2^{nd} -Feb- 2021) may act as support for prices going forward. At present one need to adopt cautiously positive on the market as stock specific move is likely to continue.
