Nifty opened gap up, but during the day we have seen minor profit booking, however it manages to close in green. At present, price breach supply zone intraday basis and close above that also. In coming trading session if prices trade above 11500 levels then it is likely to test 11560 - 11590 levels. On the downside, 11440 - 11400 levels may act as support for the day.

On the daily chart we are observing breakout of consolidation, which indicates upside will remain continue. Broadly, we are of the opinion that Nifty manages to close comfortably above the supply zone of 11036 to 11433 with good volumes, now we could see levels of 11600 – 11750 levels in couple of weeks. Hence cautiously positive approach should be adopted at current level as stock specific activity is likely to continue.
