Nifty opened higher traded in a narrow range with positive bias throughout the day to close in green. On the daily chart we are observing a golden crossover (50-days SMA cutting 200-days SMA) which suggests that momentum on the upside is likely to continue. In coming trading session if prices trade above 11620 levels then it is likely to test 11750 – 11800 levels. On the downside, 11400 - 11300 levels may act as support for the day.

Since, the prices are trading above the supply zone of 11036 to 11433 with good volumes there is high probability that momentum on the upside is likely to continue. We maintain our stance that stock specific activity is likely to continue.
