Nifty opened higher but was unable to sustain the opening gains and witness selling pressure in the first half the session. However, in the latter half of the session Nifty recovered some of it's in the latter half of the session to close in red. On the daily chart we are observing that prices breached the 50-day-SMA (15664) but have convincingly closed above it. In coming trading session if Nifty for first hour trades above 15767 then it may test 15870–15980 levels. On the downside, 15610– 15520 levels may act as support for the day.

We still continue to maintain our stance that stock specific activity is likely to continue in small and Mid-cap stocks.
