

The trend toward textile exports in the entirety of Q1FY25 remains a mixed bag as buying traction from international retailers is on the rise, especially in key markets of the US and Europe. Large players such as Target and Walmart have come back with their home textile demand, though demand for garments remained muffled due to rising inflation and central bank attempts to curb it with interest rate hikes, large clothing brands have also slowed their purchases as they hold high-cost clothing inventory.

Rice exports also remain mixed, but the general sentiment on the rice export market is negative, due to payment issues from distributors in middle eastern markets, logistical issues from ongoing geopolitical concerns and government restrictions on exports of certain types of rice. In addition to this, the Indian rice crop has not been yielding good harvests (compared to previous years). However, a silver lining is the fact that most companies are starting to diversify their distributor base both within existing countries and into new ones as well.

Indo Count Industries, Kitex Garments witnessed strong double-digit growth in exports. Raymond, Gokaldas exports and Alok Industries witnessed a growth decline in Q1FY25.

Indo count Industries exports grew by 14.8% YoY to INR 3,145mn (-0.2% MoM) in Jun-24. Indo count Industries exports grew by 32.1% YoY (-23% QoQ) to INR 8,650mn as of Q1FY25. Kitex Garments exports grew by 11.6% YoY to INR 366mn (-34.4% MoM) in Jun-24. Kitex Garments exports grew by 37.7% YoY (+6.2% QoQ) to INR 1,433mn as of Q1FY25.

Reliance Chemotex exports de-grew by 34.7% YoY to INR 98mn (-5.8% MoM) in Jun-24. Reliance Chemotex exports de-grew by 17.7% YoY (-16.6% QoQ) to INR 417mn as of Q1FY25. Raymond exports grew by 18% YoY to INR 144mn (-11% MoM) in Jun-24. Raymond exports de-grew by 5.1% YoY (-9.7% QoQ) to INR 448mn as of Q1FY25. S P Apparels exports degrew by 35% YoY to INR 385mn (-38.5% MoM) in Jun-24. S P Apparels exports de-grew by 12.7% YoY (-33.6% QoQ) to INR 1,447mn as of Q1FY25.

Gokaldas Exports Ltd exports grew by 53.3% YoY to INR 2,185mn (+12.8% MoM) in Jun-24. Gokaldas Exports Ltd exports grew by 24.9% YoY (+1% QoQ) to INR 5,139mn as of Q1FY25. Alok Industries exports de-grew by 56.3% YoY to INR 334mn (-50.7% MoM) in Jun-24. Alok Industries exports de-grew by 4.5% YoY (-52.5% QoQ) to INR 1,859mn as of Q1FY25.

LT Foods and KRBL witnessed double digit growth in Q1FY25: LT Foods exports de-grew by 4.4% YoY to INR 1,433mn (-32.6% MoM) in Jun-24. LT Foods exports grew by 26.3% YoY (+3.3% QoQ) to INR 5,797mn as of Q1FY25. KRBL exports de-grew by 45.2% YoY to INR 203mn (-72.7% MoM) in Jun-24. KRBL exports grew by 18.6% YoY (-50.1% QoQ) to INR 1,607mn as of Q1FY25. GRM Overseas exports de-grew by 36.2% YoY to INR 654mn (-5.4% MoM) in Jun-24. GRM Overseas exports de-grew by 40.3% YoY (-45.7% QoQ) to INR 1,909mn as of Q1FY25.

Pharma exports remain mixed in Q1FY25: Wockhardt exports grew by 142.8% YoY to INR 491mn (-4.1% MoM) in Jun-24. Wockhardt exports grew by 68.9% YoY (-16.1% QoQ) to INR 1,551mn as of Q1FY25. Marksans Pharma exports grew by 74.3% YoY to INR 884mn (+6.2% MoM) in Jun-24. Marksans Pharma exports grew by 43.6% YoY (+7.4% QoQ) to INR 2,399mn as of Q1FY25. Gufic Biosciences exports grew by 200.2% YoY to INR 122mn (-45.8% MoM) in Jun-24. Gupic Biosciences exports grew by 132.1% YoY (+77.9% QoQ) to INR 454mn as of Q1FY25. Gland Pharma exports de-grew by 4% YoY to INR 2,221mn (-14% MoM) in Jun-24. Gland Pharma exports grew by 49.9% YoY (+11% QoQ) to INR 7,911mn as of Q1FY25. Ami Organics exports grew by 136.7% YoY to INR 929mn (+232.1% MoM) in Jun-24. Ami Organics exports grew by 129.7% YoY (-51% QoQ) to INR 1,332mn as of Q1FY25.

Natco Pharma exports de-grew by 64.6% YoY to INR 373mn (-0.1% MoM) in Jun-24. Natco Pharma exports de-grew by 43.2% YoY (-40.8% QoQ) to INR 954mn as of Q1FY25. Biocon exports de-grew by 72.4% YoY to INR 329mn (-35.7% MoM) in Jun-24.

Exports update - Q1FY25

Biocon exports de-grew by 47.9% YoY (-50.3% QoQ) to INR 1,091mn as of Q1FY25. Divis Lab exports de-grew by 94% YoY to INR 482mn (-91.3% MoM) in Jun-24. Divis Lab exports de-grew by 37.9% YoY (-33.4% QoQ) to INR 9,367mn as of Q1FY25. Tatva Chintan Pharma Chem exports de-grew by 92.9% YoY to INR 25mn (-83% MoM) in Jun-24. Tatva Chintan Pharma Chem exports de-grew by 53.7% YoY (-36% QoQ) to INR 406mn as of Q1FY25.

India Glycols witnessed strong growth in Q1FY25: India Glycols exports grew by 61% YoY to INR 535mn (-9.7% MoM) in Jun-24. India Glycols exports grew by 38.8% YoY (-14.2% QoQ) to INR 1,322mn as of Q1FY25. IOL Chemicals exports de-grew by 6.1% YoY to INR 321mn (-38% MoM) in Jun-24. IOL Chemicals exports grew by 0.7% YoY (-2.8% QoQ) to INR 1,245mn as of Q1FY25. Navin Fluorine International exports grew by 1.1% YoY to INR 971mn (+73.1% MoM) in Jun-24. Navin Fluorine exports de-grew by 12.8% YoY (+12.5% QoQ) to INR 1,710mn as of Q1FY25.

Packaging exports were mixed in Q1FY25: EPL exports grew by 8.5% YoY to INR 293mn (+30.9% MoM) in Jun-24. EPL exports grew by 17% YoY (+22.1% QoQ) to INR 749mn as of Q1FY25. Polyplex Corporation exports grew by 71.2% YoY to INR 547mn (-17% MoM) in Jun-24. Polyplex Corporation exports grew by 76% YoY (+11.7% QoQ) to INR 1,677mn as of Q1FY25. Uflex exports de-grew by 74.3% YoY to INR 322mn (-79.9% MoM) in Jun-24. Uflex exports de-grew by 15.8% YoY (-7.2% QoQ) to INR 3,222mn as of Q1FY25.




Exhibit 2: Polyplex witnessed 76% YoY growth in Q1FY25.




Exhibit 3: Chemical exports remain mixed, however India Glycols witnessed 38.8% YoY growth in Q1FY25.





Exhibit 4: Lupin, Marksans Pharma and Gland Pharma witnessed double digit growth in Q1FY25.
