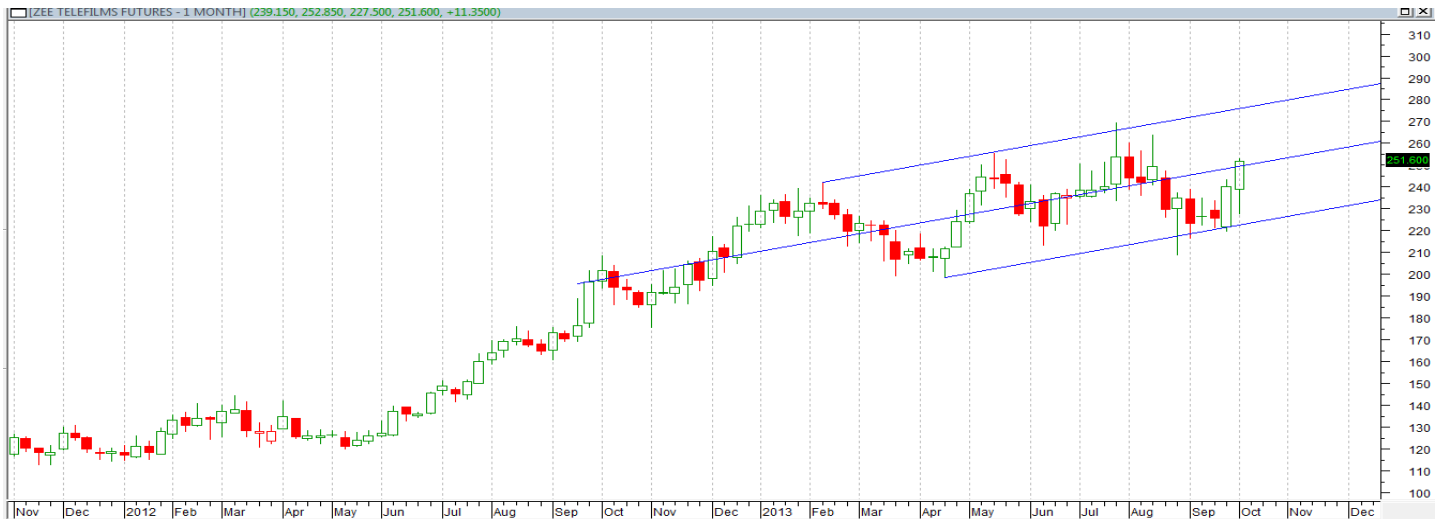

Aggressive traders can keep a stop loss of 244 for a target of 265- 275 – 282 - 296. Conservative traders can keep a stop loss 230 for the above targets.
