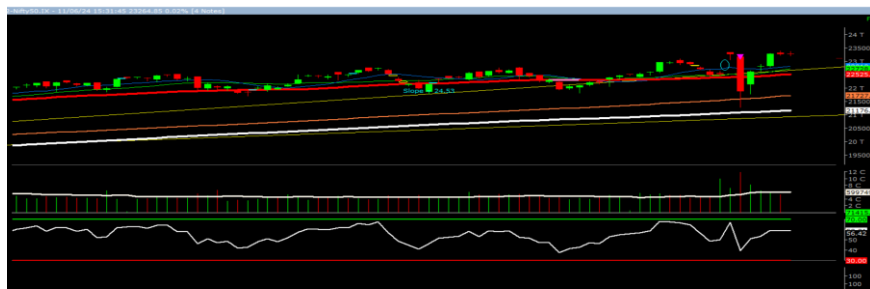

Market Technical Outlook



Nifty opened higher traded in a narrow range throughout the day to close marginally in green. On the daily chart, we are observing two consecutive narrow range body formation, which suggests that markets are circumspect at higher level. In coming trading session if nifty trades above 23310 level then it may test 23350 - 23460 levels. On the downside, 23140 - 23060 levels may act as support for the day.

We still maintain our stance that looking at the current price action & the breath of the market it is evident that momentum on the upside is likely to continue. Hence, one can adopt cautiously positive approach at current level, as stock specific activity is likely to continue.
