Nifty opened up with a gap, traded in a narrow range throughout the day with positive bias to close in green. On the daily chart, we are observing an upward gap area in the range of 21953 to 21968. Normally, upward gaps do act as support for the prices. In coming trading session if nifty trades above 22070 level then it may test 22150 - 22230 levels. On the downside, 21910 – 21790 level can act as support for the day.

Broadly, the current price action with an upward gap area suggests that sentiments are positive and even the breath of the market remains positive. Hence, momentum on the upside is likely to continue. We maintain our stance that there is high probability that nifty may test the prior all-time high of 22126 or even extend its gains further. However, stock specific activity is likely to continue.
