On the daily chart, we are observing, that nifty made a new all-time high of 23889 and formed a positive candle. This suggest that momentum on the upside is likely to continue. In coming trading session if nifty trades above 23890 level then it may test 23950 - 24060 levels. On the downside, 23745 - 23660 levels may act as support for the day.

Broadly, looking at the current price action it is evident that momentum on the upside is likely to continue. Hence, one can adopt cautiously positive approach at current level, as stock specific activity is likely to continue.
